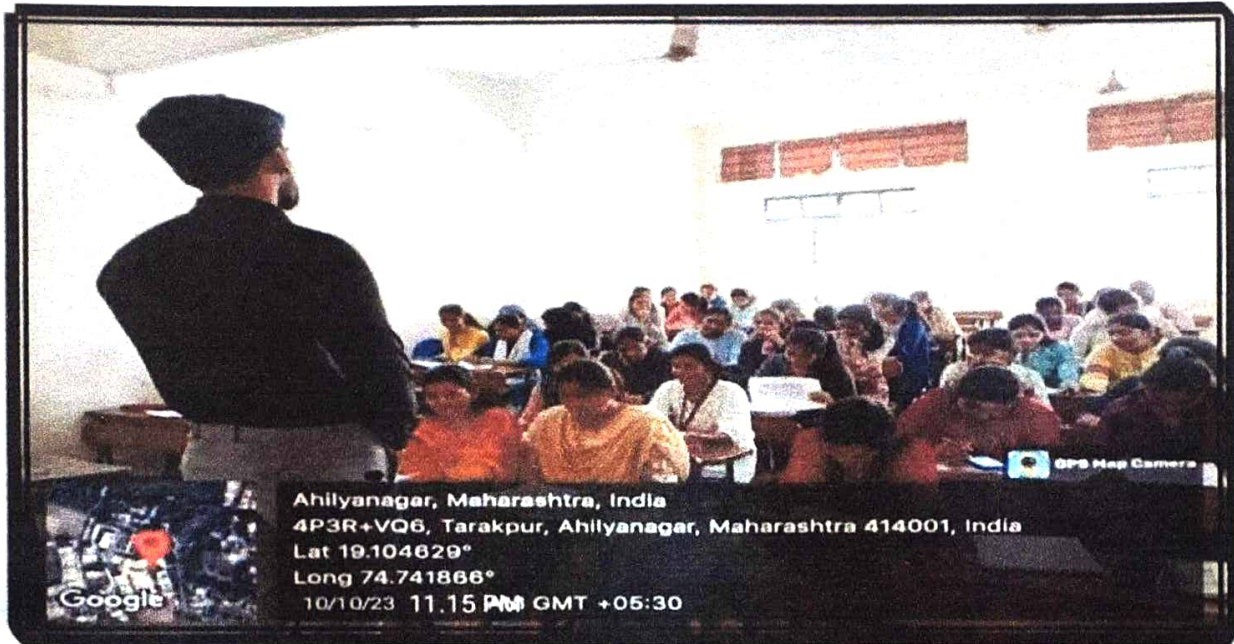

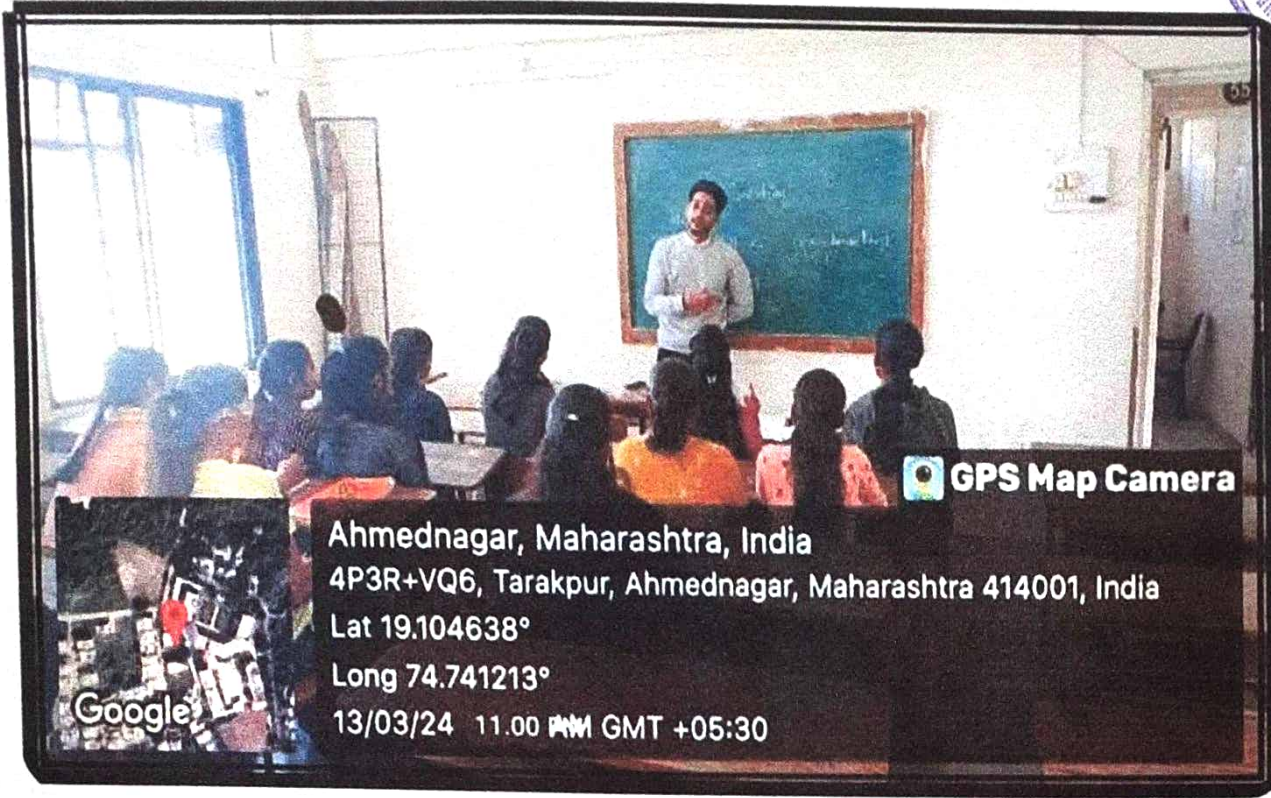

Skill Based Certificate Course in Taxation – Introduction to Tax Concepts

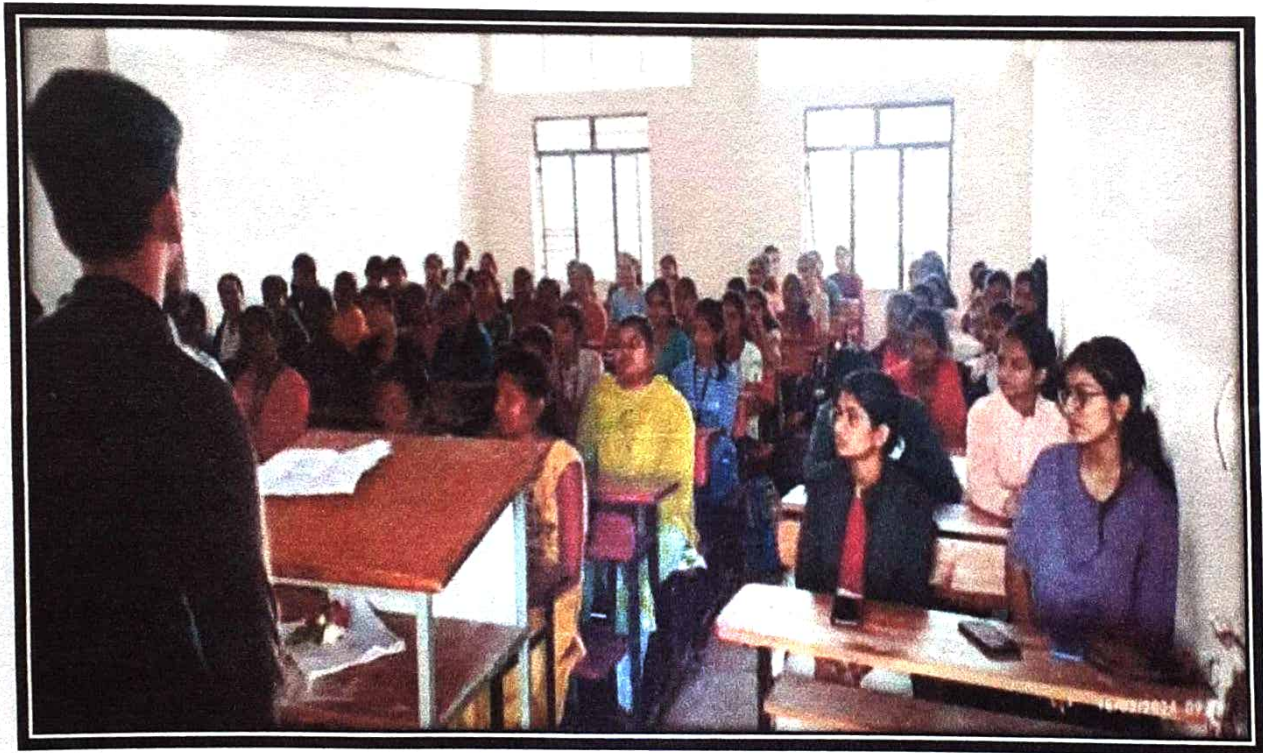


Skill Based Certificate Course in Taxation – How to Calculate Tax?

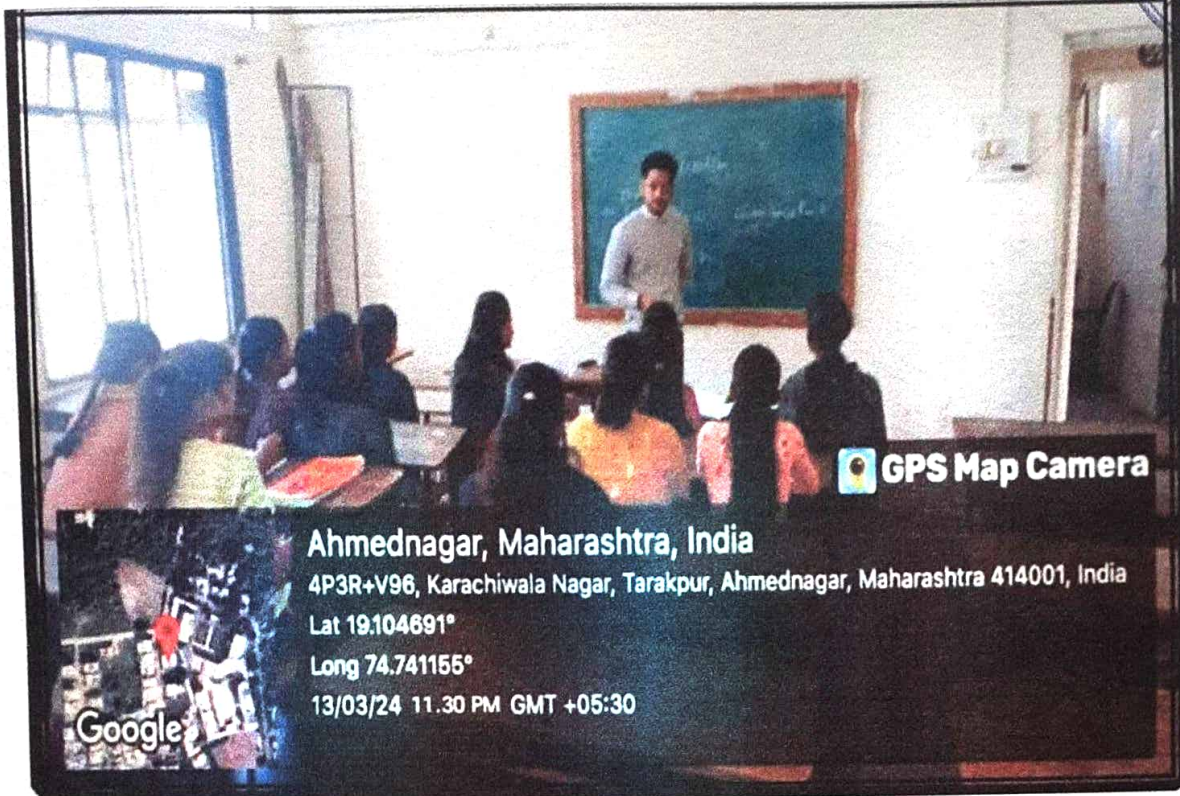

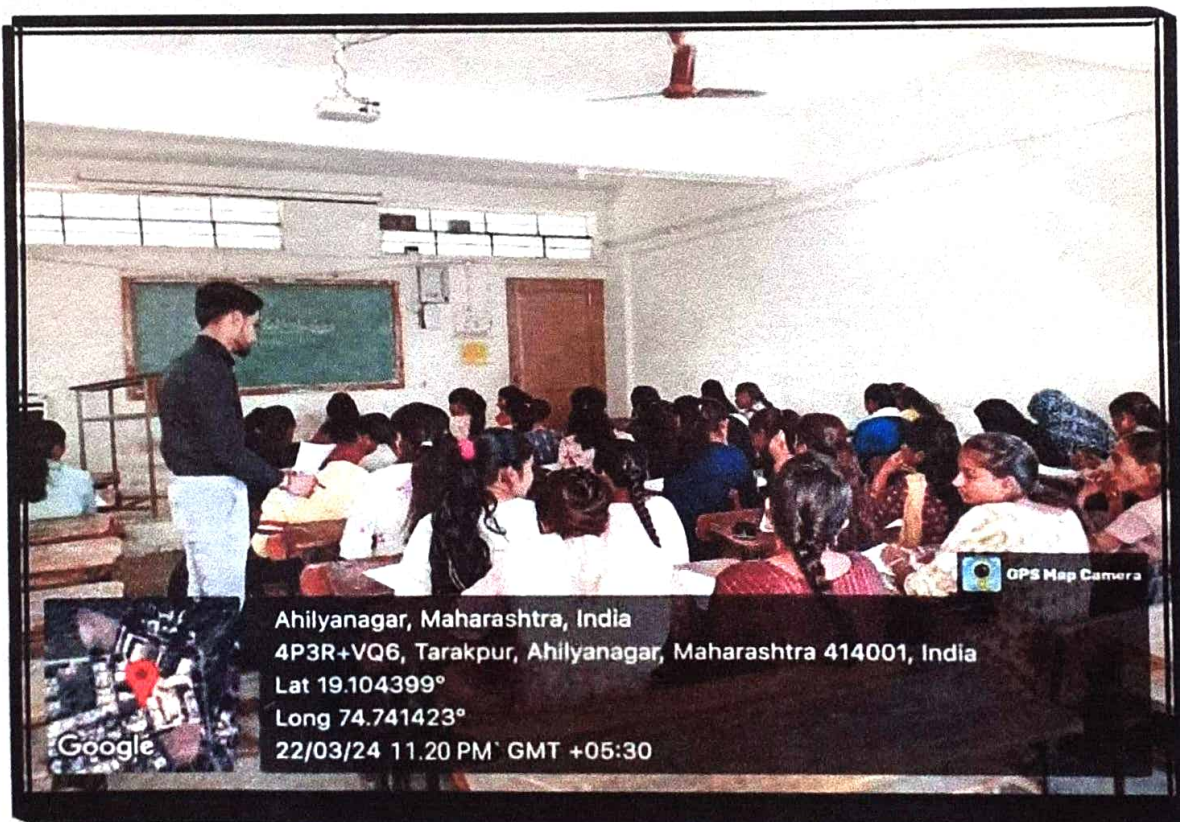
