

Whereas the Authorized Institute is offering the following courses to its under graduate, post graduate students as a value addition and to increase their employability and has agreed to provide coaching and conducting the practical's for the students registering with KVP for facing the evaluation of the said courses on the terms and conditions herein after set-forth.

- I) KVP will prepare the syllabi of the Short Term Courses for the students of higher education level.
- II) The Authorised institute also can prepare the syllabi of Short Term Courses at its level for its students.
- III) The Authorised institute will finalise the list of courses to be run during the particular year and get it approved by KVP along with the syllabi.
- IV) The Authorised Institute will designate a faculty to co-ordinate the working of these courses.
- V) The Authorised Institute will arrange for the expert trainers to train the students so that the particular skills will be inculcated in the students.
- VI) KVP will arrange for the expert committee to evaluate the performance of the students of the Short Term Courses. And if the committee finds any short comings in running the courses, the same will be conveyed to the Authorised institute.
- VII) On the demand by the Authorised institute, KVP will provide the required Certificates for the students who will complete the courses successfully.
- VIII) The Authorised institute will pay KVP, 5 % amount of the total fee collection from the students of Short Term Courses, as the administrative charges.
- IX) This agreement is regarding Short Term/Certificate/Diploma/An Advanced Diploma Courses mentioned in adjoined list.
- X) Validity of this agreement is from -2023-24 to 2026-27
